





RESOLUTION 11-3, 2025

AUTHORIZING THE VILLAGE ADMINISTRATOR TO ENTER INTO AN EMERGENCY
MEDICAL SERVICES AGREEMENT WITH MIAMI TOWNSHIP, CLERMONT COUNTY
AND DECLARING AN EMERGENCY

WHEREAS, Terrace Park desires to provide advanced emergency medical services to its residents through an Agreement with the Miami Township Fire and EMS Department; and

WHEREAS, Miami Township desires to provide advanced emergency medical services to the residents of Terrace Park.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF TERRACE PARK,
HAMILTON COUNTY, OHIO that:

Section 1. The Village Administrator is hereby authorized to enter into an Emergency Medical Services Agreement with Miami Township, substantially in the form of the Agreement attached hereto as Exhibit A and incorporated herein by reference.

Section 2. The three separate readings required by law are hereby waived. This Resolution shall be acted upon as an emergency in order to authorize the agreement at the earliest possible date and shall become effective immediately.


Section 3. That the Village Clerk be, and she hereby is directed to publish this Resolution by posting a copy thereof as heretofore determined by Council.


