**RESOLUTION APPOINTING VICTORIA TREMAYNE AS FULL-TIME POLICE OFFICER FOR THE VILLAGE OF TERRACE PARK POLICE DEPARTMENT AND DECLARING AN EMERGENCY**

**WHEREAS**, the complement of full-time Police Officers for the Village of Terrace Park is in need of an additional Police Officer.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF TERRACE PARK, HAMILTON COUNTY, OHIO that:**

**Section 1.** Victoria Tremayne be appointed as a full-time Police Officer at the probationary annual rate of compensation of \$72,800, effective January 16, 2026.

**Section 2.** Council hereby waives the three separate readings of this Resolution according to law. Furthermore, the Council hereby adopts this Resolution as an emergency for the reason that it is necessary to provide for such appointment in a timely manner in order to maintain the continuity of public safety.

**Section 3.** The Village Clerk is hereby authorized and directed to publish this Resolution in the manner heretofore determined by Council.




**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF


**SECTION 2.** Council hereby waives the three separate readings of this resolution and hereby advances it to the third and final reading.

**SECTION 3.** That the Village Clerk be, and she hereby is directed to publish this Resolution by posting a copy thereof as heretofore determined by Council.


