

VILLAGE OF TERRACE PARK, HAMILTON COUNTY, OHIO

RESOLUTION NO. 3-1, 2023

STRONGLY URGING THE OHIO GOVERNOR AND MEMBERS OF THE OHIO GENERAL ASSEMBLY TO RESTORE THE LOCAL GOVERNMENT FUND TO PRERECESION LEVELS AND DECLARING AN EMERGENCY

WHEREAS, the Local Government Fund was reduced in 2011 by 50% during Gov. Kasich's Administration from 3.68% of General Revenue Funds to its current level of 1.66% of General Revenue Funds; and

WHEREAS, past Ohio General Assemblies have repeatedly decreased funding and revenue sharing in recent years in addition to significantly reducing the Local Government Fund, including eliminating the Estate Tax and phasing out the Tangible Personal Property Tax; and

WHEREAS, these reductions have resulted in a loss of revenue of \$370,000 for the Village of Terrace Park; and

WHEREAS, this sudden revenue loss has made it increasingly difficult to provide basic services, rebuild infrastructure, and bolster public safety services; and

WHEREAS, when municipalities experience success in fostering safe communities, building sound infrastructure, and increasing economic development, the State of Ohio reaps the benefits as well.

WHEREAS, a reinvestment in the Local Government Fund would aid the state in its goal of lowering taxes on the individual by enabling municipalities to decrease the local tax burden.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF TERRACE PARK, HAMILTON COUNTY, OHIO that:


Section 1. The Ohio General Assembly should restore the Local Government Fund to prerecession levels, ensuring that local communities are able to provide crucial services and improvements in infrastructure and public safety.

Section 2. This Council does hereby declare its opposition to any further cuts to the Local Government Fund or the future diversion of revenues from the Local Government Fund.


Section 3. Council hereby waives the three separate readings of this Resolution according to law. Furthermore, the Council hereby adopts this Resolution as an emergency for the reason that it is necessary to restore the Local Government Fund at the earliest possible date.

Section 4. The Village Clerk is hereby authorized and directed to publish this Resolution by posting a copy hereof in the five most public places in the Village as heretofore determined by Council.



RESOLUTION 3-2 , 2023

**FIXING THE SALARIES AND RATINGS OF VILLAGE EMPLOYEES EFFECTIVE
MARCH 16, 2023**

BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF TERRACE PARK,
STATE OF OHIO

SECTION 1. That the salary of the Chief of Police of the Village of Terrace Park shall range from \$101,569.90 - \$107,755.99 per annum for scheduled work hours.

SECTION 2. That the salary of Police Lieutenant of the Village of Terrace Park shall range from \$98,364.59 – \$101,315.52 per annum for scheduled work hours.

SECTION 3. That the salary of Police Sergeant of the Village of Terrace Park shall range from \$88,302.93 - \$93,680.57 per annum for scheduled work hours.

SECTION 4. That the salary of Patrol Officers shall range from \$77,083.63 - \$86,940.13 per annum for scheduled work hours.

SECTION 5. That the salary of maintenance personnel shall range from \$28.02 – \$31.15 per hour for laborers and \$34.32 – \$36.40 per hour for maintenance foreman.

SECTION 6. That the salaries shall be payable in equal semi-monthly installments. Scheduled work hours per annum shall be 2,080 work hours. All hours worked in excess of the scheduled work hours may be returned to the employee in compensated time off at the rate of one and a half per each hour worked or pay at one and a half times the hourly rate if approved by the Chief of Police in the case of full-time Police Officers, full-time Maintenance Workers and Probationary Officer. Approval of pay in lieu of compensated time off for additional work in excess of scheduled work hours shall be totally within the discretion of the approving authority.

Determination of overtime pay due for hours worked in excess of scheduled work hours may awarded or paid on the next regular pay period as the approving authority deems most appropriate, as adjusted for compensation time which may be exercised in accordance to policy.

SECTION 7. That the salary of part-time patrol officers of the Village of Terrace Park shall range from \$15.00 (training) to \$19.09 per hour.

SECTION 8. That the salary for the Administrative Assistant / Village Clerk shall range from \$17.72 - \$18.79 per hour.

SECTION 9. That the salary for Mayor's Court Clerk shall range from \$25.00 - \$25.75 per hour.

SECTION 10. That the salary for the Chief Fiscal Officer shall range from \$25.70 - \$27.26 per hour.

SECTION 11. That the annual salary for Village Administrator shall range from \$21,875.39 - \$23,207.59

SECTION 12. That the salary for the Urban Forester shall range from \$27.90 - \$29.59 per hour


SECTION 13. That future employee across the board pay raises commencing March 16, 2022 through March 15, 2025 must be approved by council and will not exceed, during the aforementioned dates, an annual increase of 3%. Council has the discretion to review individual salaries and adjust compensation accordingly at any time.

SECTION 14. That the foregoing salary schedule shall become effective March 16, 2023. All Ordinances, Resolutions, and regulations, heretofore passed and adopted providing for such salaries, and/or wages are hereby repealed on that date.



SECTION 16. That this Resolution be advanced to the third reading and shall become effective March 14, 2023.



RESOLUTION 3-3, 2023

CONSENT OF COUNCIL TO THE APPOINTMENT BY THE MAYOR OF MEDDIE JON KALEGI TO THE
VOLUNTEER EMERGENCY MEDICAL SERVICES DEPARTMENT
