ORDINANCE NO. 2-1-24

ORDINANCE AMENDING SECTION 10.19(A) OF THE
TERRACE PARK CODIFIED ORDINANCES REGARDING
PUBLICATION BY POSTING

WHEREAS, the Village of Terrace Park has adopted certain regulations regarding the publication of summaries of ordinances and resolutions and other Village information; and

WHEREAS, after review, the Rules & Law Committee has recommended certain changes to those regulations; and

WHEREAS, Council now desires to adopt said recommendation.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE
VILLAGE OF TERRACE PARK, HAMILTON COUNTY, OHIO, that:

Section 1. Section 10.19(A) of the Terrace Park Codified Ordinances is hereby amended as follows:

§ 10.19 PUBLICATION BY POSTING.

(A) If no newspaper is generally circulated in the municipality, publication of summaries of ordinances and resolutions, and publication of all statements, orders, proclamations, notices and reports, required by law or ordinance to be published, shall be accomplished by posting copies thereof on the Village website and in the lobby of the Village Administration Building, for a period of not less than 15 days prior to the effective date thereof.


Section 2. All other provisions of the Codified Ordinances not specifically amended herein shall remain in full force and effect.

Section 3. This Ordinance shall be effective from and after the earliest period allowed by law.



WHEREAS, the complement of Auxiliary Police Officers for the Village of Terrace Park is in need of an additional Auxiliary Police Officer.



Section 1. Thomas Wells be appointed as an Auxiliary Police Officer effective August 9, 2022, at the rate of \$1.00 per annum.



Section 3. The Village Clerk is hereby authorized and directed to publish this Resolution in the manner as heretofore determined by Council.


