AUTHORIZING AND DIRECTING THE VILLAGE ADMINISTRATOR TO ENTER INTO AN AGREEMENT WITH THE JK MEURER CORP. FOR THE 2024 STREET MAINTENANCE AND REPAIR PROGRAM AT A COST NOT TO EXCEED \$74,810 AND DECLARING AN EMERGENCY

WHEREAS, the Council of the Village of Terrace Park desires to provide safe roadways to provide for vehicular traffic; and

WHEREAS, the Village of Terrace Park Council has received a proposal from The JK Meurer Corp. for various paving repairs.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF TERRACE PARK, HAMILTON COUNTY, OHIO that:

Section 1. It is hereby determined that The JK Meurer Corp. has submitted the lowest and best bid for performing said street maintenance and repair work.
