

MINUTES OF MEETING
December 9,2025
VILLAGE OF TERRACE PARK COUNCIL
HAMILTON COUNTY, OHIO

Council met on Tuesday December 9 at 6:00 p.m. in the Terrace Park Community Building. Mayor Tepe led Council in the Pledge of Allegiance. Members of Council present were Mr. Jeff LeMay, Mr. Pax Lindell, Mr. John Gaskey, Ms. Lauren Ingebritson, Ms. Judith Lehman and Ms. Regina Sharp. In addition, Mayor Tom Tepe, Village Administrator and Police Chief Gerald Hayhow, Chief Fiscal Officer and Clerk of Council, Katie Lyons, EMS Chief John Maggard, Fire Chief George Heffner, and Solicitor Mr. Jeff Forbes

The Mayor asked if anyone had any corrections, additions or deletions to November 12,2025 Minutes. Council Member Judith Lehman motioned to approve and council member Jeff LeMay seconded the Council Minutes from November 12,2025, Council Meeting. Voice vote, all voted, aye. Minutes approved.

RESIDENTS TO ADDRESS COUNCIL The Mayor asked if there were any residents to address council, seeing none, he moved on.

MAYOR'S REPORT:

The Mayor thanked the residents for the approval of the Levy and has committed to keeping everything on track. New Council starts in January.

The Mayor thanked all the people that make the Village of Terrace Park the best place to live. He then thanked each person individually. (please see list attached)

The Mayor thanked council member Judith Lehman for her time and support that she has dedicated to the Village of Terrace Park. She challenged issues and made all sides of every issue be examined.

The Mayor thanked council member Jeff LeMay he has served as Vice Mayor and Finance Chair, he has examined the budget from every angle through the years and tackled the Levy with the utmost professionalism.

Judith Lehman and Jeff LeMay were gifted the Oath of Office engraved in glass as a memory for their 12 years of work. Ms. Lehman and Mr. LeMay thanked the Mayor, Council and the residents for the opportunity to be part of the workings of the Village of Terrace Park.

The Mayor announced the swearing in of the new Council Members will happen prior to the January 13,2026 Council Meeting.

Chief Fiscal Officer- Katie Lyons -No Report.

Solicitor: Jeff Forbe's-No Report.

Clerk of Council: Katie Lyons -No Report.

EMS CHIEF: Chief Maggard announced that the January 2026 EMS Class has 11 people that are interested.

FIRE CHIEF: Chief Heffner reported the following:

- TFPD was called to help with trench rescue, squad helped with rehab for firefighters on the scene. Engine was moved to station 29 to staff the station and handle additional calls. The

following members helped: Chris Gleason, John Maggard, Ken Caskey, Ty Zimmerman, DJ Bruce, Craig Russell and Chris Dixon.

- An open house, held in October, gathered some interest from people to join TPFD. He will follow up with them and look into a new class.
- Awarded 2026 MARCS Grant Award from Ohio to help buy new radios. The Grant is for \$42,000.
- He reminded residents to clear fire hydrants of snow, keeping at least 3-4 feet around the hydrant clear of snow.

POLICE CHIEF/VILLAGE ADMINISTRATOR: Chief Hayhow reported that leaf pick up continues but has been delayed due to mechanical issues on the leaf truck and the unexpected early snow. The leaf pickup will continue, if need be, in January. He asked residents to be patient and that no leaf will be left behind.

MEMBERS OF COUNCIL OUTSIDE THEIR COMMITTEE:

Reports, Resolutions & Ordinances of Standing Committee: None

Planning & Zoning –Mr. Gaskey -Zoning meeting on November 17, 2026 and a follow up meeting in December.

Finance –

Council Member LeMay introduced and advanced to the third reading **ORDINANCE 12-1, 2025 2026 FINAL APPROPRIATIONS** Lehman seconded. Gaskey, Ingebritson, Lindell, LeMay, Lehman and Sharp voted aye. LeMay then moved to adopt the ordinance as an emergency. Ingebritson seconded. Gaskey, Ingebritson, Lindell, LeMay, Lehman and Sharp voted aye.

Buildings & Grounds –Regina Sharp. Ms. Sharp thanked Shawn Crowley for the beautiful shelter that he donated to the village in honor of his wife, Kristen Crowley. She then said the work of Ohio River Foundation did a great job clearing the acre of invasive species and will consider clearing more.

Rules & Law -Judith Lehman-no report.

Public Works- Pax Lindell- explained that this resolution is accepting the bid to begin the Elm Water Main Infrastructure project. The grant from the federal government will cover the cost of this, along with cash on hand from the assessment that we started with the water fund. Mayor Tepe explained that Council has been working on this for couple of years, with multiple meetings, all of which have been open to the public and that this is critical to our infrastructure. Council Member Gaskey asked if this assessment would end after the project. Mr. Lindell explained that the water assessment was set up to collect \$100,000 a year and covers repairs of the water line along with replacement of fire hydrants. The Village owns all the water lines which is a huge cost. Chief Hayhow stated the federal government grant was for \$400,000 of the total project. The Village is responsible for the remainder of the cost. When a water main breaks there are parts of Terrace Park that are without access to water. This is critical for the safety of our residents. Mr. Lindell reminded residents that multiple meetings were conducted prior to placing an assessment on the Water Bill for each home.

Council Member Lindell introduced and advanced to the third reading **RESOLUTION 12 -1, 2025 AUTHORIZING AND DIRECTING THE VILLAGE ADMINISTRATOR TO ENTER INTO AN AGREEMENT WITH LARRY SMITH, INC. FOR THE 2025 ELM AVENUE WATER MAIN INFRASTRUCTURE IMPROVEMENTS PROJECT AT A COST NOT TO EXCEED \$557,213.50 AND DECLARING AN EMERGENCY** Gaskey seconded.

Gaskey, Ingebritson, Lindell, LeMay, Lehman and Sharp voted aye. Lindell then moved to adopt the resolution as an emergency. Sharp seconded. Gaskey, Ingebritson, Lindell, LeMay, Lehman and Sharp voted aye. Resolution passed as an emergency.

Public Safety – Lauren Ingebritson explained this stays on track with our theme of safety. The Mayor reminded residents that while this was budgeted, it was put on hold due to other expenses. Mr. LeMay thanked Chief Hayhow for his patience and prioritizing other department needs, but we do have cash on hand to purchase the vehicle.

Council Member Ingebritson introduced and advanced to the third reading **RESOLUTION NO. 12-2, 2025 RESOLUTION AUTHORIZING THE PURCHASE OF A 2026 FORD EXPLORER AT A PRICE OF \$44,669.00** Sharp seconded. Gaskey, Ingebritson, Lindell, LeMay, Lehman and Sharp voted aye. Ingebritson then moved to adopt the resolution as an emergency. Lindell seconded. Gaskey, Ingebritson, Lindell, LeMay, Lehman and Sharp voted aye. Resolution passed as an emergency.




