
WHEREAS, Council now desires to repeal Resolution 4-2, 2025.

6 members elected thereto concurring:


Section 1. That Resolution 4-2, 2025 is hereby repealed in its entirety and shall have no further force or effect.

Section 2. That this Resolution shall be effective from and after the earliest period allowed by law.



Section 1. Victoria Tremayne be appointed as a part-time Police Officer at the compensation of not to exceed \$30.00 per hour.



Section 3. The Village Clerk is hereby authorized and directed to publish this Resolution in the manner heretofore determined by Council.



RESOLUTION 8-3, 2025

**AUTHORIZING AND DIRECTING THE VILLAGE ADMINISTRATOR TO ENTER INTO AN
AGREEMENT WITH MACQUEEN EQUIPMENT, LLC FOR THE PURCHASE OF ONE HORTON
TYPE I AMBULANCE AT A COST NOT TO EXCEED \$292,410.00
AND DECLARING AN EMERGENCY**

WHEREAS, the Sourcewell Cooperative Purchasing Program has advertised and received bids for the purchase and installation of equipment under the national bid Program; and

WHEREAS, MacQueen Equipment, LLC was the best bidder with a bid of \$292,410.00 for the purchase of one (1) Horton Type 1 ambulance for use by the Village.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE VILLAGE OF TERRACE PARK, HAMILTON COUNTY, OHIO that:


Section 1. It is hereby determined that MacQueen Equipment, LLC has submitted the lowest and best bid for said equipment. The Village Administrator is hereby authorized and directed to enter into a contract with MacQueen Equipment, LLC on the terms and conditions as provided for in the proposal attached hereto as Exhibit A, incorporated herein by reference.

Section 2. The Village Administrator is hereby directed by Council to enter into an agreement with MacQueen Equipment, LLC for an amount not to exceed \$292,410.00.


Section 3. The three separate readings required by law are hereby waived. This Resolution shall be acted upon as an emergency in order to enter into the contract before the expiration of the bid.

Section 4. The Village Clerk is hereby authorized and directed to publish this Resolution in the manner as heretofore determined by Council.


